**Midian Shrine Kids Run
Release and Waiver of Liability, Assumption of Risk,
and Indemnity (“Agreement”)**

I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue in the Event.

I fully understand that Midian Shrine Kids Run event involves risks of serious bodily injury, including impairment disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the “releasees” named below; and that there may be other risks ether not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and responsibility for losses, costs, and damage I incur as a result of my participation in the Event.

I hereby release, discharge, and covenant not to sue Midian Shiners, Shriners International, Shriners Hospitals for Children, their respective administrators, directors, agents, officers, volunteers, and employees, other participants, and sponsors and advertisers and if applicable, owner and lessors of premises on which the Event takes place, (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by negligence of the releases or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the releases, I will indemnify, save, and hold harmless each of the releases from any loss, liability, damage or cost which any may incur as result of such claim.
